②Banning Trespass Non-Fishing Vessels refers to cases where Coast Guard Administration (CGA) expels sand suction dredger (carrier) or expels (detains) cargo ships, merchant ships, oil tankers, etc. that have simply trespassed; as for those who use ships to trespass for smuggling, illegal immigration, illegal sandstone quarrying, etc., they are classified into respective industries according to criminal patterns.
