



海巡大破毒窟之 戒護記

A journal of custody-The Coast Guard Administration ferrets out drugs

3 月2日台中查緝隊和岸巡第三總隊聯手破獲了一安非他命製造工廠，起出安非他命八百多公克、半成品兩千三百多公克、一小包海洛因以及完整的製毒工具與原料，市值近千萬元並逮捕了一嫌犯，而我被指派擔任戒護的工作。第一次如此近距離的與嫌犯面對面，替嫌犯繫上冰冷的手銬腳鐐，讓我強烈感受到身為海巡署人員的使命感。剛見到嫌犯時有點驚訝，他並不如我所想的一副凶神惡煞模樣，而是一個再平凡不過的年輕人。經過偵訊後，才發現真正的製毒主嫌是他父親，嫌犯父親利用兒子所開的茶葉行當掩護，進行毒品加工與買賣，在逮捕過程中父親狡猾逃脫，只有兒子落網，事件發生後，父親瞬間斷了連絡，所有家人也

The Taichung Anti-smuggling team and the third Coast Guard Headquarter ferret out an amphetamine manufacturer on March 2nd. More than 800 grams of amphetamine, more than 2300 grams of semi-finished goods of that, a small bag of heroin and a complete set of manufacturing tools and raw materials. The total market price of the above products is nearly NT\$10,000,000 and a suspect was caught. I was assigned to the custody task and it was the very first time for me to be so close to a suspect. I put on the handcuff and shackle on him and felt so strong the mission as a staff member of the Coast Guard Administration,



無法和他聯繫上。嫌犯父子之間的親情，在這大難臨頭之時，也因各自飛去而煙消雲散。嫌犯的表情看起來格外的平靜，不知是因為早已知道有這麼一天，還是腦袋因無法思考而一片空白，直到母親和女友帶著律師來見他的時候，終於再也按捺不住心中的情緒，掩面哭泣，似乎是無顏面對自己的親人，母親也不敢相信自己心目中乖巧的兒子竟會犯下如此滔天大罪，情緒幾乎崩潰。眼前一位心碎的母親看著帶著手銬腳鐐的兒子，心中滿是悔恨與不捨，或許在此時，她最想責備的其實是自己吧！

在戒護的過程中，輪班的三位弟兄必須無時無刻的守著他，無論如廁、睡眠、走動、用餐等行為，都要受到嚴密的監控，以避免發生嫌犯逃脫及

I was really surprised by the time I saw the suspect, for he was such an ordinary guy, not like what I thought. After a police interrogation, we found that the real drug dealer was his father. The tealeaf store owned by the son was used to screen all drug manufacturing and selling works. The father got away and only the son was captured. The father disappeared after that and lost contact forever. This guy looked quite peaceful and I wondered if he already knew it would happen some day or he could think. He could not resist anymore and cry out until he saw his mother and girlfriend came along with a lawyer. The mother came apart at the seams and could not believe that her son has committed enormous crime. She was heart broken and rueful and I guess she would never blame her son but herself on that.

During custody, three staff workers must take turns for three shifts. We must stay with him anytime, anywhere, whether washing up, sleeping, walking and eating. He must be kept under close watched to prevent from escaping or self-hurting, for drug dealing is such a felony and suspects of that might try all they can do to resist sanctions. we staff workers rely on our trainings to be able to adjust to circumstances.

I looked at his face at midnight and he was not different from other people. I could stop recalling some of the recent news: A drug abuser who was going through withdraw drove in a speed of 130km/hr with his friends and bumped into the car in opposite lane; five died and one (car in opposite lane) seriously injured. A young female abuser who was also going through withdraw made herself to prostitution to get some money for drugs. A person with drug misuse record and has regenerated himself beat a professor of National Taiwanese University to death when going through

自我傷害的事件，畢竟，販毒是重罪，嫌犯往往會想盡辦法脫逃或是以死逃避法律的制裁，心理狀況極為不穩定，因此隨機應變的能力便要仰賴平時的訓練成果。

深夜裡，看著嫌犯睡著的臉，就如同普通人一般平靜安祥，但我腦中卻浮現了近日以來的新聞：毒癮發作的駕駛載著一車毒友在縣道上狂飆，以130公里的車速正面撞上對向來車，除了對向車的一名乘客重傷以外，其餘五員當場死亡；毒癮發作的少女賣淫籌錢買毒；吸毒前科更生人毒發，活活打死台大教授。這些新聞，離我們好像很遙遠，卻又是那麼真實、那麼接近我們的生活，或許哪一天，受害者可能就是我們的親人、朋友，甚至是我們自己。這些都因為毒品而起，而販毒者，卻看不見這些殘酷的悲劇，就如同眼前的嫌犯，並不知道自己犯了多麼不可原諒的大錯，間接毀滅了多少人的一生、多少原本美滿的家庭，而他卻仍安穩的睡著，我的內心深深為他感到悲哀。

第二天早上，地檢署檢察官抵達查緝隊並開了記者會，各家媒體爭相報導，檢察官與海巡署各級長官都表達了堅定的反毒決心，希望將這禍國殃民的毒品永遠消滅。下午，筆錄程序與偵訊都逐一完成，接下來是移送的階段，我們的戒護工作也將告一段落。看著嫌犯一步一步遠去的背影，腦海裡仍充斥著吸毒者和受害人的影像，如迴音般不停在我腦中環繞著，久久不能散去。

看見人性的脆弱與無知，嫌犯面對母親懊悔、痛哭的神情令人不勝唏噓，早知如此，又何必當初呢？雖然戒護時間僅短短的2天，卻讓我碰到了許多平時不會接觸的狀況，感謝長官給我這次的機會，讓我獲得了珍貴的經驗，同時也體認到海巡勤務的重要性與身為海巡人的光榮使命。🙏

withdraw. All the above seem so real and so close to our lives and one day, the victims could be our relatives, friends or even us. Drugs cause them all and it is pathetic that the drug dealers fail to understand the tragedy. They do not understand they have not only ruined their lives but also others'. I feel so sorry for the suspect in front of me, for he does not know what he has done and still sleeps well.

The following morning, the prosecuting attorney of the District Prosecutors Office arrived at the anti-smuggling team office for a press conference. Prosecutors and all commissioners of the Coast Guard Administration declare firmly their resolution to say no to drugs and to wipe out them. My job came to an end when the suspect was removed after his statement has been taken down and the interrogation has been completed. The images of drug abusers and victims filled up my head and though he has gone far, images will not fade away.

When I saw the suspect crying in front of his mother, I could not stop wondering: "Why wouldn't you think more before you did it?" During those 2 days, I realized how fragile and innocent human beings could be and I have also encountered so much that I would not have faced in everyday life. I would like to say thank you to my supervisor for giving me this chance. I have not only learnt a lot but have also come to understand the importance of this job and honour of being a staff worker in Coast Guard Administration.
