# 自行車踏板藏K 遭海巡人員緝獲

Coast Guard Reconnaissance Brigade  
Tracked ***Ketamine*** Hidden in  
Bicycle Pedals

9年7月21日臺灣桃園地方法院檢察署檢察官何嘉仁指揮海巡署北部地區巡防局台北機動查緝隊會同岸巡第一二、一三、二一大隊、第十六海巡隊及臺北市政府警察局大同分局、臺北市政府警察局北投分局大屯派出所等單位組成專案小組共同偵破由鄒○○、林○○為首之「K他命」走私販毒集團，並查獲走私入境之第三級毒品

On July 21, 2009, Ho Jia-zen, public procurator in Taoyuan District Court, Taiwan ordered Taipei Reconnaissance Brigade, Coast Guard Administration with Coast Patrol Corps 1-2, 1-3-2-1, Maritime patrol Flotilla 16, Taipei City Police Da-tung Branch, and Beitou Branch to form a specialized investigation team to track down the Ketamine drug dealer group led by suspects Zou and Lin. The specialized investigation team success-

「K他命」毛重約三十公斤，成功阻止毒品流入市面。

整起案件係台北查緝隊於日前接獲情資，以鄒、林2嫌為首之販毒集團其成員眾多且有黑道背景，長期將毒品販賣予桃園地區酒店、PUB、汽車旅館、電子遊藝場等場所之不特定人士，戕害國人身心莫此為甚。案經專案小組多日蒐證調查後，趁鄒、林2嫌駕車從桃園住處相約前往台中地區運輸大量毒品之際，隨即展開收網工作；查緝人員鎖定鄒、林2嫌所駕駛白色自小客車，於98年7月21日18時40分由台中北上行經國道中山高速公路「楊梅收費站」回數票車道時，見機不可失立即配合國道高速公路警察局同仁進行攔查，當時鄒嫌已搖下車窗準備繳交回數票，因車上散發濃厚「K他命」毒品氣味而露餡，查緝人員在取得鄒嫌同意後檢查車內物品，並於車輛後座及後行李箱中發現6只大紙箱，經專案小組人員鑑定，發現紙箱內裝有大量黑色塑膠自行車腳踏墊，且於腳踏墊周邊發現白色不名粉末及濃厚氣味，以試劑初步檢驗後，發現自行車腳踏墊中「白色不名粉末」呈現「K他命」毒品反應，隨即將2嫌逮捕。

據了解該走私販毒集團，懂得利用台灣現今最流行的自行車腳踏墊中間軸心空間來夾藏大量毒品，足見其細密的犯罪思維，與其擁有之專業生產製造技術，勢必加深日後查緝人員執行任務時之艱難；本案雖然極具挑戰，但終究在查緝人員日以繼夜的努力下，圓滿達成。全案共計查獲毒品數量計有1,228罐，重量高達30公斤。

海巡署強調，天堂和地獄僅是一線之隔，千萬別上「毒品」的當，也別為了「毒品」而把家庭搞得支離破碎。對於戒毒者我們要給予協助與鼓勵，讓他們用毅力與耐心來突破戒毒的難關重獲新生。唯有拒絕「毒品」的誘惑，才能讓台灣的環境更健康，成為亞洲快樂無毒的新國度。

fully tracked down around 30 kg of Ketamine and stopped the drug flowing into the market.

The whole crime case was initiated as Taipei Reconnaissance Brigade received information that the drug dealer group, formed by gangsters and led by suspects Zou and Lin, was selling drugs to bars, Pubs, motels, arcades in Taoyuan district. The drug dealer group had caused damage to many victims' mental and physical conditions. The specialized investigation team investigated the crime case for a period of time, and decided to end the investigation when suspects Zou and Lin transported drugs from Taoyuan to Taipei. The Taipei Reconnaissance Brigade aimed at the white car drove by suspects Zou and Lin. At 18:40 on July 21, 2009, suspects drove pass the lane near Yangmei ticket booth on Zhongshan Highway. The Taipei Reconnaissance Brigades together with the Highway Police stopped and investigated the white car. Suspect Zou rolled down the window and the smell of Ketamine was very thick and leaking out of the car. The Taipei Reconnaissance Brigade obtained the permission from the suspects and investigated inside the car. The brigade found six big cardboards. After specialized investigation team examined the cardboards, there was a large quantity of bicycle pedals and there were unknown white power around each pedal with the smell of Ketamine. As analyzed with chemical test paper, the unknown white powder showed the reaction result of Ketamine. The brigade arrested the suspects right away.

As information showed that the drug dealer group used the empty space inside bicycle pedals to hide Ketamine. As the trend of the careful planning and utilizing the manufacturing profession of bicycle in this drug crime, it is getting more difficult for the Reconnaissance Brigade to execute drug investigation mission. Although this crime was full of challenge, it was still tracked down as the Reconnaissance Brigade investigated the case day after day. There were 128 bottles of drugs, weighted 30 kg in total, tracked down in this crime case.

The Coast Guard Admission emphasized that there is only one line to cross from heaven to hell. One should never fall into the trap of drug and should never break up with family just for drugs. One should give encouragement and assistance to help people who are trying to quit drugs to resist the temptation of drugs. This way can improve the living environment in Taiwan, and making Taiwan become a joyful country without drug.
