His determination to preserve human rights and justice has led to his ardent involvement in numerous cases applying for the Grand Justices' interpretation of the Constitution and his appointment as a Member of the Presidential Advisory Committee on Human Rights.

Ted L. McDorman is a Professor at the Faculty of Law, University of Victoria, Victoria, British Columbia, Canada. He has written widely on ocean law and policy issues having published over 130 articles, chapters in books, etc. From 1984 to 2002, Professor McDorman was part of the CIDA/IDRC funded Southeast Project on Ocean Law, Policy and

Management (SEAPOL) centered in Bangkok, Thailand.

Since 2000, he has been editor-in-chief of *Ocean Development and International Law*. Jay L. Batongbacal (Speaker)




Jay L. Batongbacal holds degrees in Political Science and Law, as well as advanced degrees of Master of Marine Management and Doctor in the Science of Law. Since 1997, he has done diverse work and widely published in maritime affairs, including community based fisheries management, coastal resource management, marine environment

protection, maritime boundaries, high seas fishing, offshore energy, seafaring, and shipping. He has also conducted, upon request, many briefings and submitted opinions to various government offices, such as the Office of the President, the Department of Foreign Affairs, Department of National Defense, National Security Council, Cabinet Committee on Maritime and Ocean Affairs, the Committee on Foreign Affairs of the House of Representatives, the Committee on National Defense of the Philippine Senate, among others. He remains actively involved with both government and non-government organization on many different issues involving a maritime component, including the mining and petroleum industries.

Mr. Batongbacal was legal advisor to the Philippine delegation that successfully pursued the Philippines' claim to a continental shelf beyond 200 nautical miles in the Benham Rise Region before the Commission on the Limits of the Continental Shelf in accordance with the United Nations Convention on the Law of the Sea (UNCLOS). He is currently assisting the Philippines in making an application to the International Maritime Organization for the designation of a Particularly Sensitive Sea Area in the Sulu Sea. He is also on his second term on the UNESCO List of Experts on Marine Scientific Research for purposes of Special Arbitration under UNCLOS Annex VIII. He recently completed research on US maritime security policy and the South China Sea disputes under the auspices of the US-ASEAN Fulbright Initiative Visiting Scholar Program. Presently, he serves as an Associate Professor at the University of the Philippines College of Law, and concurrently Director of the Institute for Maritime Affairs and Law of the Sea of the U.P. Law Center.

Wu Shichun (Chair)

President National Institute for South China Sea studies

Wu Shicun has a PhD in history and is president and senior research fellow of China's National Institute for South China Sea Studies, deputy director of the Collaborative Innovation Center of South China Sea Studies, Nanjing University, and member of Foreign Policy Advisory Group of the Ministry of Foreign Affairs of China.

Dr Wu's research interests cover the history and geography of the South China Sea, maritime delimitation, maritime economy, international relations and regional security strategy. His main single-authored books include What One Needs to Know about the Disputes between China and the Philippines (Current Affairs Press, 2015), What One Needs to Know about the South China Sea (Current Affairs Press, 2015), Solving Disputes for Regional Cooperation and Development in the South China Sea: A Chinese perspective (Woodhead Publishing, 2013). His main edited books include: Arbitration Concerning the South China Sea: Philippines versus China (Routledge, 2016), UN Convention on the Law of the Sea and the South China Sea (Ashgate, 2015), Non-Traditional Security Issues and the South China Sea-Shaping a New Framework for Cooperation (Ashgate, 2014), Recent Developments in the South China Sea Dispute: The Prospect of a Joint Development Regime (Routledge, 2014). Dr Wu has published widely in academic journals and been the subject of frequent media interviews as a senior commentator on South China Sea, and other regional security issues.



Warwick Gullett (Speaker)

Professor Warwick Gullett was Deputy Director of the Australian National Centre for Ocean Resources and Security (ANCORS) prior to being appointed Dean of Law at the University of Wollongong in 2012. His research interests focus on legal protection of the marine environment and the international law of the sea. He is the author of *Fisheries Law in Australia* (335pp, LexisNexis Butterworths, 2008) and co-editor of

Asia-Pacific and the Implementation of the Law of the Sea: Regional Legislative and Policy Approaches to the Law of the Sea Convention (230pp, Brill/Nijhoff, 2016) and Marine Resources Management (359pp, LexisNexis Butterworths, 2011). Professor Gullett is Current Legal Developments Editor for the Asia-Pacific Journal of Ocean Law and Policy.

Professor Gullett has written extensively on laws regarding the marine environment, in particular focusing on fisheries law, marine protected areas, marine resource management and

jurisdictional issues. His work has been cited by the International Tribunal for the Law of the Sea, Commonwealth Administrative Appeals Tribunal, NSW Land and Environment Court and the South Australian Environment Resources and Development Court. South China Sea, Nanjing University. He has conducted research at a number of institutions including the University of Tokyo, Harvard University, Georgetown University, Oxford University, Durham University, and George Washington University, and has taught at Xiamen University, China (2009), University of Hawai'i at Mānoa, USA (2013), and Zhejiang University, China (2013).

He is Chairman of the Foundation for the Development of International Law in Asia (DILA) (2012-2015) and now serving as Chairman of the Development of International Law in Asia-Korea (DILA-KOREA) which is a new academic entity which is responsible for DILA along with the *Asian Yearbook of International Law* (AsianYbIL) and Asia Pacific Ocean Law Institutions Alliance (APOLIA).

He is a member of the Advisory Board for the Sustaining Coastal and Marine Zones of the University of Wollongong (UOW) Global Challenges Program in Australia, a member of the board directors of the Jon Van Dyke Institute of International Law and Justice, William S. Lan-Anh T. Nguyen (Speaker)

Assoc. Prof Lan-Anh T. Nguyen is Deputy Director General of the Institute for East Sea (South China Sea) Studies and Vice Dean of the International Law Faculty of the Diplomatic Academy of Vietnam.

She is responsible for analyzing the legal aspects of the South China Sea disputes as well as other issues related to ocean law and policy. In this role, she offers legal analysis and advisory opinions to political, diplomatic, and security deliberations. Assoc.
