②取締越界非捕魚船舶係指本署驅離抽(運)砂船或驅離(扣留)單純越界之貨輪、商船、油輪等案件，至利用船舶越界進行走私、偷渡、盜砂等行為者，則依其犯罪態樣分別歸於其所屬業別。

Remark：①"Handle of Conserved Wildlife Remains" changed from Other Business Performance/Others to Maintaining Marine and Coastal Resources/ Handle of Conserved Wildlife Remains since April 2020; however, due to the fact that data from 2000 to 2011 cannot be obtained, the historical data is traced back to 2012 only.

②Banning Trespass Non-Fishing Vessels refers to cases where Coast Guard Administration (CGA) expels sand suction dredger (carrier) or expels (detains) cargo ships, merchant ships, oil tankers, etc. that have simply trespassed; as for those who use ships to trespass for smuggling, illegal immigration, illegal sandstone quarrying, etc., they are classified into respective industries according to criminal patterns.
